Announce a Meeting of the Restoration Advisory Board**

NASJRB and ARS, Willow Grove, Pennsylvania announce a scheduled meeting of the Restoration Advisory Board (RAB). The meeting will be held on Wednesday, July 14, 1999, at 6:00 PM. All current RAB members are encouraged to attend and the public is invited. The purpose of the meeting is to discuss comments or concerns the community and RAB members may have regarding environmental issues at NASJRB and ARS, Willow Grove. A short tour of environmental sites of current interest will precede the meeting. The Air Force will summarize the status of investigations/actions underway at Air Force installation restoration sites. The Navy will present a summary of the soil removal action underway at Site 1 – Privet Road Compound Area to remediate polychlorinated biphenyls (PCBs).

All RAB meetings are open to the public. Technical support staff is available to provide information and answer questions.

Anyone wishing to bid farewell to Commander Terray Wood, the NASJRB Willow Grove Executive Officer and RAB Co-Chairperson, is urged to attend, as this will be his last RAB meeting before he is reassigned to Washington D.C.

Community members interested in learning about Air Station environmental issues or RAB membership are encouraged to attend. The next NASJRB and ARS, Willow Grove RAB meeting will be held on Wednesday, July 14, 1999 at 6:00 PM. The meeting will convene in the Navy's Conference Room on the second floor of Building 1.

Access to the facility for the RAB meeting will be through the NASJRB (Navy) main gate, located on Easton Road (Route 611). Parking for the RAB meeting will be available behind (west of) Building 1, which is across the traffic circle just inside the Navy's main gate. Directions to Building 1 will be provided by the uniformed guard at the gate.

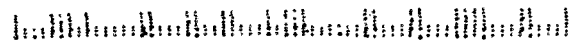
